

CHAPTER 168

OFFICIAL SALARIES ORDER NO. 4 OF 1992

An Order to amend the schedule to the Official Salaries Act [CAP. 168].

IN EXERCISE of the powers conferred by section 3 of the Official Salaries Act [CAP. 168], I, MAXIME CARLOT, Prime Minister and Minister of Public Service, Planning and Statistics, Media Services and Language Services, with the prior approval of the Council of Ministers, hereby make the following order:-

2. Part 2 of the schedule to the Act is amended by repealing "CLASS B" and substituting the following class:-



