

THE PHYSICAL PLANNING ACT No.22 OF 1986

DECLARATION OF EAST EFATE, SOUTH EFATE, ERAKOR, PANGO, IFIRA AND
MELE AREA COUNCILS TO BE PHYSICAL PLANNING AREAS

IN ACCORDANCE with Section 2 (1) of the Physical Planning Act [Cap. 193], the Efate Local Government Council hereby declares East Efate, South Efate, Erakor, Pango, Ifira, and Mele Area Councils to be Physical Planning Areas for the purpose of development in accordance with the said Act.

In accordance with Section 2 (3) of the said Act, the Efate Local Government Council has decided that the following types of development shall not require permission for development :

1. The carrying out of works for the maintenance, improvement or other alteration of any building if the works only affect only the interior of the building and do not materially affect the external appearance of the building.
3. The carrying out of works by a public authority required for the maintenance or improvement of a road if the works are carried out on land within the road reserve.
4. The carrying out by any public authority or statutory undertaker or of any works for the purpose of inspecting, repairing or renewing any sewers, pipes, cables or other apparatus including the breaking open of any other land for that purpose.
5. The use of any building or other land within the curtilage of a dwelling house for any purpose incidental to the enjoyment of the dwelling house.
6. The use of any land and associate buildings, though not living accomodation, for the purpose of livestock keeping, agriculture, fishing or forestry.


As defined in Section 1 of the Physical Planning Act [Cap. 193], "Development" means the carrying out of building or other operations in, on, over or under the land or the making of any material change in the use of buildings or land, or the subdivision of any land.

No person shall carry on development in a Physical Planning Area,

except as specified in the Declaration of that Physical Planning Area, without having first received permission in writing from the Council.

This Declaration shall take effect from the date of publication of this notice in the gazette.



INSTRUMENT OF RATIFICATION

NIUE TREATY ON COOPERATION IN FISHERIES SURVEILLANCE
AND LAW ENFORCEMENT IN THE SOUTH PACIFIC REGION


WHEREAS:

- A. The Niue Treaty on Cooperation in Fisheries Surveillance and Law Enforcement in the South Pacific Region (hereinafter referred to as the "Treaty") was signed in Niue, on 9 July, 1992;
- B. Article XIII(2) provides that -
- (i) the Treaty shall be subject to ratification;
 - (ii) such ratification shall be effected by the deposit of an instrument to that effect with the Government of Niue;
- C. By virtue of the Niue Treaty on Cooperation in Fisheries Surveillance and Law Enforcement in the South Pacific Region (Ratification) Act No. 10 of 1993 the Parliament of the Republic of Vanuatu ratified the Treaty;
- D. The Council of Ministers of the Republic of Vanuatu has empowered and authorized the Prime Minister and Minister responsible for Foreign Affairs to sign this Instrument of Ratification on behalf of the Republic of Vanuatu;

NOW THEREFORE the Republic of Vanuatu HEREBY NOTIFIES the Government of Niue of its ratification of the Treaty.

IN WITNESS THEREOF I, MAXIME CARLOT KORMAN, Prime Minister and Minister responsible for Foreign Affairs of the Republic of Vanuatu, have on the day hereinafter specified signed this Instrument of Ratification and affixed hereto the seal of the Prime Minister of the Republic of Vanuatu.
