- A. Le 12 août 1994, le ministre de l'Intérieur a nommé MARTIN JAMES TETE pour étudier la situation du Conseil municipal de Luganville conformément au paragraphe 1) de l'article 61 de la Loi No. 5 de 1980 relative aux Communes (CAP. 126) (ci-après dénommée la Loi) ;
- B. Le 16 août 1994, Martin James Tété lui a soumis un rapport ;
- C. Après avoir soigneusement et dûment étudié ce rapport, le Ministre conclut qu'il est suffisamment justifié et opportun d'exercer les pouvoirs que lui confère le paragraphe 3) de l'article 61 de la Loi ;

EN CONSEQUENCE, VU les pouvoirs que lui confère le paragraphe 3) de l'article 61 de la Loi, le ministre de l'Intérieur prend par les présentes les décisions suivantes :

- 1) Le Conseil municipal de Luganville est dissous à compter de la date de l'entrée en vigueur de la présente décision.
- 2) Les élections de nouveaux conseillers auront lieu le 31 janvier 1995 au plus tard.
- 3) A compter de la date de la dissolution effective jusqu'à la constitution d'un nouveau Conseil suite aux élections prévues au paragraphe 2) ci-dessus, BABA LUC FRANÇOIS exercera tous les pouvoirs que confère à ce Conseil municipal la Loi No. 5 de 1980 relative aux Communes (CAP. 126) ou toute autre législation.
- 4) Les présentes décisions entreront en vigueur à la date de la signature du présent instrument.
