CHAPTER 168

OFFICIAL SALARIES ORDER NO. 8 OF 1996

To amend the Schedule to the Official Salaries Act [CAP. 168].

IN EXERCISE of the powers conferred upon me by section 3 of the Official Salaries Act [CAP. 168], I, MAXIME CARLOT KORMAN, Prime Minister and Minister of Public Service, Planning and Statistics, Media and Language Services, with prior approval of the Council of Ministers, hereby make the following Order -

AMENDMENT OF PART 1 OF THE SCHEDULE TO CHAPTER 168

- 1. Part 1 of the Schedule to the Official Salaries Act [CAP. 168] is amended as follows -
 - (a) by deleting the figure "2.712.000" corresponding to the item "Prime Minister" and substituting therefor the figure "2.800.000";
 - (b) by deleting the figure "1.836.000" corresponding to the item "Deputy Prime Minister" and substituting therefor the figure "2.640.000".

COMMENCEMENT

- 2. (a) The provision of section 1(b) shall be deemed to have come into force on 1st March, 1996.
 - (b) The provision of section 1(a) shall take effect on the date of signature.


