CHAPTER 146

REPRESENTATION OF THE PEOPLE (POLLING DISTRICTS)  
(AMENDMENT) ORDER NO. 16 OF 1996

To amend the Representation of the People (Polling Districts) Order No. 16 of 1991.

IN EXERCISE of the powers conferred upon the Electoral Commission by sections 4 and 69 of the Representation of the People Act [CAP. 146], the Electoral Commission makes the following Order: -

**AMENDMENT OF SCHEDULE TO ORDER NO. 16 OF 1991**

1. The Schedule to the Representation of the People (Polling Districts) Order No. 16 of 1991 is amended -
  - (a) in the Efate Constituency in the registration area number 3.01.05 after polling station "C. Ifira" by adding "D. BLACKSAND";
  - (b) in the Port Vila Constituency by adding the following new polling stations -

"G. VILA NORTH SCHOOL  
H. PAKAROA CHURCH  
I. MUNICIPAL STADIUM.";
  - (c) in the Santo/Malo Constituency -
    - (i) in the registration area number 1.03.04 by deleting "B.VALPEI" and substituting "B. BETHANY";
    - (ii) in the registration area number 1.03.04 by adding the following new polling stations -

"H. RAVLEPA  
I. OLPOE".





An order to prescribe the powers, functions and duties of a magistrate in respect of matters before an Island Court concerning disputes as to ownership of land.



NOMINATION OF MAGISTRATE TO PRESIDE IN LAND MATTERS

1. (1) Magistrate Mr Regget Marum is hereby nominated to preside over Island Courts on all land matters arising in all areas and districts of Vanuatu.
2. (2) Furthermore, he shall perform his powers, functions and duties, pursuant to the Island Courts (Powers of Magistrates) Order No. 1 of 1990, as published in the Official Gazette No. 1 of 1990.
