

DECLARATION OF LAND IN SANMA REGION  
TO BE PHYSICAL PLANNING AREAS

---

IN ACCORDANCE with Section 2 [1] of the Physical Planning Act [Cap. 193], the SANMA Local Govt Council hereby declares the following land Titles 04/2234/001, 04/2612/003, 640, 620, 619, 04/2612/001, 04/2621/001, 04/2614/002, 04/2623/002, 04/2641/010, 04/2643/007, 04/2643/008, 04/3021/005, 04/3022/002, 4115, 04/2293/001, 04/2632/009, 04/2641/005, 04/2641/002, 04/2641/004, 04/2641/001, 04/2632/004, 04/2632/008, 04/2632/002, 04/2632/006, 04/2632/010, 04/2633/001, 04/2632/007, 04/2644/001, 04/2634/002, 04/2641/007, 04/2641/008, 04/2632/015, 04/2943/003, 04/2943/005, 04/2943/006, 04/2634/005, 04/2943/004, 04/3024/002, 04/2643/007, 04/3022/005, 04/2632/011, 04/2613/001, 04/2643/001, 04/3024/008, 04/3022/003, 04/2943/008, 04/2641/009, 04/3024/007, 04/2943/009, 04/3024/006, 04/2243/001, 04/3012/001, 04/3013/001, 04/2611/001, 04/2634/003, and 04/3014/001 on Santo mainland, the island of Aore and the islets of Ratua, Urelapa, Tavana, Urenarave, Venui, Urenahuepe, Tangisi, Maltinerava, Kervimele, Malono, Malwepe, Malparavu, Malvapevu, Malvanua and Malao in the SANMA Region to be Physical Planning Areas for the purpose of development in accordance with the said Act.

In accordance with Section 2 [3] of the said Act, the SANMA Local Govt Council has decided that the following types of development shall not require permission for development :-

1. The carrying out of works for the maintainance, improvement or other alteration of any building if the works only affect the interior of the building and do not materiall affect the external appearance of the building.
3. The carrying out of works by a public authority required for the maintainance or improvement of a road if the works are carried out on land within the road reserve.
4. The carrying out by any public authority or statutory undertaker or of any works for the purpose of inspecting, repairing or renewing any sewers, pipes, cables, or other apparatus including the breaking open of any other land for that purpose.

5. The use of any building or other land within the curtilage of a dwelling house for any purpose incidental to the enjoyment of the dwelling house.
6. The use of any land and associate buildings, though not living accomodation, for the purpose of livestock keeping, agriculture, fishing or forestry.

As defined in Section 1 of the Physical Planning Act [Cap. 193], "Development" means the carrying out of building or other operations in, on, over or under the land or the making of any material change in the use of buildings or land, or the subdivision of any land.

No person shall carry on development in a Physical Planning Area, except as specified in the Declaration of that Physical Planning Area, without having first received permission in writing from the Council.

This Declaration shall take effect from the date of publication of this notice in the Government Gazette.
