### LOCAL GOVERNMENT COUNCILS (DATE OF ELECTIONS) ORDER NO. 33 OF 1997

To declare the date for the start of elections for councillors to the TORBA Local Government Council.

IN EXERCISE of the powers conferred by section 32(4) of the Decentralization and Local Government Regions Act No. 1 of 1994, and rule 1 of the Local Government Council Election Rules Order No. 61 of 1982, as amended, the Electoral Commission, hereby makes the following order:-

#### DATE OF ELECTION

1. The election for councillors to the TORBA Local Government Council shall commence on the 11<sup>th</sup> day of September, 1997.

#### RETURN OF LIST AND CANDIDATURE


2. (1) Eligible persons may submit their declarations of candidature for the Local Government Council as from the date of the commencement of this Order until not later than 4:30 p.m. on Tuesday the 26<sup>th</sup> day of August, 1997 to the Principal Electoral Officer in Vila or to the Secretary of the dissolved local Government Council.

- (2) In this section 2(1) "dissolved Local Government Council" means the TORBA local government council dissolved under the Decentralization (Dissolution of Local Government Council) Order No. 32 of 1997.

**COMMENCEMENT**

3. This Order shall be deemed to have come into force on the 12<sup>th</sup> day of August, 1997.







**POLICE ACT [CAP. 105]**

**POLICE (GRATUITY) ORDER NO. 36 OF 1997**

To prescribe the rate for payment of gratuity in relation to a permanent disablement attributable to a wound, injury or sickness contracted by a member in such circumstances as are specified in section 32A. of the Police Act [CAP. 105].

**IN EXERCISE** of the powers conferred upon me by section 82(c a) of the Police Act [CAP. 105], **I, ROBERT D. KARIE**, Minister of Home Affairs, make the following Order:-

**RATE FOR PAYMENT OF GRATUITY**

1. (1) Where, as a direct consequence of any wound, injury or sickness received or contracted by a member in the circumstances specified in section 32A of the Police Act [CAP. 105], the member is compulsorily retired from the Force, the member shall be entitled to a gratuity payable at the rate of one and one half month's salary for every completed year, calculated at pro rata for any incomplete year, that the member was employed by the Force.
- (2) For the avoidance of doubt –
  - (a) "Force" means the Vanuatu Police Force;
  - (b) "member" means a member of the Vanuatu Police Force.

**COMMENCEMENT**

2. This Order shall come into force on the date hereof.
