





#### ARRÊTE :

##### MÉDAILLE DE LA CONSTITUTION

1. (1) Il est créé par les présentes une médaille appelée "Médaille de la Constitution de Vanuatu" (dénommée ci-après la "médaille"), destinée à être décernée en récompense aux membres de la Commission constitutionnelle des Nouvelles Hébrides, et de la Commission préparatoire.
- (2) Afin d'éviter toute confusion possible, la "Commission constitutionnelle des Nouvelles Hébrides" et la "Commission préparatoire" désignent ici les commissions établies en 1979 et chargées de rédiger la Constitution des Nouvelles Hébrides.

##### ATTRIBUTION DE LA MÉDAILLE

2. (1) La médaille est décernée pour commémorer le jour de la Constitution de la République de Vanuatu, événement historique marquant la signature de la Constitution nationale de Vanuatu.
- (2) (a) Le Président de la République de Vanuatu peut décerner la médaille sur recommandation du Premier Ministre.
- (b) Les noms des personnes qui reçoivent la médaille sont publiés au Journal Officiel.

##### DESCRIPTION DE LA MÉDAILLE, ETC

3. (1) L'avvers de la médaille porte les armoiries de la République de Vanuatu et mesure approximativement 78mm x 57mm.
- (2) Le revers de la médaille est plane.

- (3) La médaille est suspendue à un ruban large de 32mm comportant de gauche à droite des bandes diagonales de couleur rouge (10 mm), noire (4 mm) et jaune (10 mm).

#### **LE REGISTRE DES NOMS**

4. (1) Le Conservateur des nominations :
- (a) tient un registre des noms des personnes qui ont reçu la médaille; et
  - (b) y inscrit tous autres renseignements concernant l'attribution de la médaille selon les instructions du Président de la République de Vanuatu.
