CHAPTER 129

PUBLIC SERVICE ACT

PUBLIC SERVICE INSTRUCTION NO. 1 OF 1996

To amend the Public Service Instruction No. 1 of 1992.

IN EXERCISE of the powers conferred on me by section 19(1) of the Public Service Act [CAP. 129]. I, MAXIME CARLOT KORMAN, Prime Minister and Minister responsible for Public Service, Planning and Statistics, Media and Language Services, hereby issue these instructions -

AMENDMENT OF PUBLIC SERVICE INSTRUCTION NO. 1 OF 1992

1. The Public Service Instruction No. 1 of 1992 is amended by deleting paragraph 3(c) and substituting therefor the following new paragraph -

"C. NEW RATES OF OVERSEAS SUBSISTENCE ALLOWANCES


The new rates of Overseas Subsistence Allowances per night for an officer travelling on official government duty shall be -

- a) For all the Pacific Island Countries including Australia and New Zealand - VT 8.500
- b) For all other Regions i.e Europe, Asia, the Americas - VT 13.300."


