

COURT ORDERS

UPON HEARING Mr. George Vasaris, Counsel for the Petitioner and Mr. Dudley Aru, Vanuatu Financial Services Commissioner and upon reading the Petition herein dated 19th June 2001 and the Affidavit of Richard Graham Allen sworn on 5th June 2001, it was ordered by consent as follows:-


1. THAT the name of the Company shall be restored to the Register of Companies in Vanuatu;
2. THE Registrar of Companies is hereby directed to advertise in his official name in the Government Gazette, these Orders;
3. THE Company undertakes that upon restoration, it will pay all outstanding fees and penalties up to 3rd August 1993 (the "Strike Off Date");
4. THE Company undertakes that upon restoration, it will file all outstanding returns up to the Strike Off Date;
5. THE Company upon restoration shall not undertake any banking business, nor shall it hold out or represent in any way that it is an International Business Company or an International Company;
6. THE Company upon such restoration to the Register shall change its name forthwith to "La Salle IBC Limited";
7. THE Company undertakes that upon such restoration its primary purpose shall be to sue for and recover all monies outstanding to it and to execute and enforce all judgements obtained by it and all purposes necessary and ancillary thereto, however, the Company further undertakes that upon restoration, no legal action or court proceeding will be instituted against Mr. William Binns and Mrs. Pauline Mary Binns of Old Manor Cottage, Manor Lane, Little Comberton, Pershore Worcestershire, England;



8. THE costs of this Petition shall be borne by the Petitioner.
