ORDER NO.6 OF 2001

An order to prohibit the Sale and supply of liquor throughout the Islands of Santo and Malekula in the Republic of Vanuatu, in the interest of the public, peace and good order during Luganville and Malekula Constituencies National General Bye-Elections.

IN EXERCISE of the powers conferred by Section 19 of the Liquor Licensing Act (Cap 52) **I, BARNABAS TABI**, Minister of Internal Affairs and National General Bye – Elections hereby makes the following Order :-


**SALE OF LIQUOR THROUGHOUT SANTO AND MALEKULA
CONSTITUENCIES**


1. The Sale, Supply and Distribution of Alcoholic Liquor at, or on, or from Stores, and licensed Premises throughout the Islands of Santo and Malekula in the Republic of Vanuatu whether of consumption on, or off the premises is hereby prohibited from half past seven (7.30 am) in the morning of Tuesday 6th February, 2001 until 12 O'clock Midnight on Wednesday 7th February, 2001.

COMMENCEMENT

2. This Order shall come into force on Tuesday 6th February, 2001.

1. Appointment of member


Mr. Garry Blake is appointed as member of the Board of Directors of the National Bank of Vanuatu.
