VANUATU NATIONAL SPORTS COUNCIL (AMENDMENT) ACT NO 12 OF 2003

An Act to amend the Vanuatu National Sports Council Act No. 43 of 1989

Be it enacted by the President and Parliament as follows-

1 Amendments

The Vanuatu National Sports Council Act No.43 of 1989 is amended as set out in the Schedule.

2. Commencement

This Act commences on the date of its publication in the Gazette.

SCHEDULE

AMENDMENTS OF THE VANUATU NATIONAL SPORTS COUNCIL ACT NO.43 OF 1989

1 Section 1

Insert in its correct alphabetical position

“**Director General** means the Director General of the Ministry responsible for youth development and training.”.

2 Section 3

Repeal the section, substitute

“3 Composition of the Council

(1) The Council consists of 5 members.

(2) The members are:

(a) a representative of the Ministry responsible for youth development and training;
and

(b) a person with legal qualifications; and

(c) a person with architecture or engineering qualifications.

(3) The secretary and the treasurer of the Council are members of the Council by virtue of holding those offices. (see section 8)

(4) The members in subsection (2) are to be appointed by the Minister on the recommendation of the Director General.

(5) The Minister is to appoint the Chairman and Deputy Chairman from the members appointed under subsection (2).

(6) An appointed member of the Council holds office for a term of two years and can be re-appointed.

(7) All appointments made under this section are to be published in the Gazette.

3A Removal and resignation of members

- (1) The Minister may, after consultation with the Council, remove a member if he or she:
- (a) in the case of a member being a representative of the Ministry responsible for youth development and training – ceases to be an employee of that Ministry or the Minister; or
 - (b) is a person having professional qualifications and is disqualified or suspended from practicing his or her profession; or
 - (c) fails to attend 3 consecutive meetings without the permission of the Council; or
 - (d) is convicted of an offence; or
 - (e) in the Minister's opinion is not performing in a satisfactory way.
- (2) A member may resign at any time by giving his or her resignation in writing to the Minister.

3B Acting member

- (1) If a member of the Council (including the Chairperson or Deputy Chairperson) is absent from Vanuatu or is for any reason unable to perform his or her duties as a member of the Council, the Council may:
- (a) in the case of the Chairperson or Deputy Chairperson- appoint a member to act as the Chairperson or Deputy Chairperson; or
 - (b) in any other case- appoint a person to act as a member.
- (2) A person who is appointed to act is entitled to all the rights and to exercise all the powers, functions and duties of the member he or she represents.”.

3 Paragraph 4(e)

- (a) Delete “Minister”, substitute “Director General”.
- (b) After “recreation”, insert “facilities”.

4 Paragraphs 5(e), (f), (k), (l) and (m)

Delete “Minister”(wherever occurring), substitute “Director General”.

5 Subsection 7(2)

6 After section 7

Insert

"7A Sitting allowance

The members of the Council including the Chairperson and Deputy Chairperson are entitled to a sitting allowance of VT 3000 for each meeting of the Council."

7 Section 8

Repeal the section, substitute

"8 Secretary and treasurer of the Council, other officers and employees

Subject to this Act, the Council is to appoint, at such remuneration and upon such terms and conditions as it thinks fit:

- (a) a secretary to the Council who is to manage the day to day administration of the Council; and
- (b) a treasurer to the Council; and
- (c) such other officers and employees as may be required for the proper and efficient discharge of the functions of the Council."

8 Subsections 13(2) and (4)

Delete "Minister"(wherever occurring), substitute "Director General".

9 Section 14

Repeal the section, substitute

"14 Annual Reports

- (1) The Council must prepare an annual report of its operations within 3 months after the end of each year and provide a copy of the report to the Director General.
- (2) The Local Government Councils and Municipal Councils must prepare an annual report to the Council of their operations within 3 months after the end of each year".

1 Article 1

Insérer selon l'ordre alphabétique :

"Directeur général désigne le Directeur général du ministère du Développement et de la formation de la Jeunesse."

2 Article 3

Supprimer et remplacer cet article par :

"3 Composition du Conseil

- 1) Le Conseil se compose de cinq membres.
- 2) Les membres sont :
 - a) un représentant du ministère du Développement et de la formation de la Jeunesse ;
 - b) une personne diplômée en droit ; et
 - c) une personne diplômée en architecture ou en ingénierie.
- 3) Le secrétaire et le trésorier du Conseil sont membres du Conseil à titre d'office (cf. : Article 8).

3A Révocation et démission des membres

- 1) Le Ministre peut après consultation du Conseil révoquer un membre si ce dernier :
 - a) s'agissant d'un membre représentant le ministère du Développement et de la formation de la Jeunesse - n'est plus un employé dudit ministère ou du Ministre ;
 - b) possède des qualifications professionnelles et à été mis dans l'incapacité, ou est frappé d'interdiction d'exercer sa profession ;
 - c) n'assiste pas à trois réunions consécutives du Conseil, sans la permission de ce dernier ;

- d) est condamné pour une infraction ; ou
- e) ne donne pas satisfaction dans l'exercice de ses fonctions, d'après le Ministre.

2) Un membre peut démissionner à tout moment sur remise de sa démission écrite au Ministre.

3B Membre intérimaire

1) Lorsqu'un membre du Conseil (y compris le Président ou le vice-président) est absent de Vanuatu ou, pour toute raison, incapable d'exécuter ses fonctions de membre du Conseil, le Conseil peut :

- a) s'agissant du Président ou du vice-président, nommer un membre à sa place à titre intérimaire ; ou
- b) dans tout autre cas, nommer une personne à sa place à titre intérimaire.

2) Une personne nommée par intérim jouit de tous les droits et a le droit d'exercer tous les pouvoirs, fonctions et devoirs du membre qu'elle représente."
