CUSTOMARY LAND TRIBUNAL ACT NO. 7 OF 2001

**Land Tribunal Members
(Ambae Tongoa and Moso) Regulation**

Order No. 25 of 2003

To notify the approval of persons as members of certain land tribunals.

In exercise of the powers conferred on me by section 44 of the Customary Land Tribunal Act. No.7 of 2001, I, the Honourable Jackleen Ruben Titek, Minister of Lands make the following Regulation.

1 Land Tribunal Members

The persons whose names appear in the Schedule have been approved in accordance with section 35 or 36 of the Customary Land Tribunal Act No.7 of 2001 to adjudicate disputes relating to boundaries or ownership of customary land.

2 Commencement

This Regulation commences on the day on which it is made.


The Hon. Mr. Justice David James Carruthers
