
1 Amendments

AMENDMENTS OF THE FORESTRY (CONTROL OF MOBILE SAWMILLS) ORDER NO. 9 OF 1996

1 Paragraph B of Schedule 5

Delete the paragraph, substitute

"B Production fees

- (1) The production fee for a mobile saw mill that produces the volume in column 1 of the table below is to be calculated by adding the corresponding amounts in columns 2, 3, and 4 of the table.

Licensed log volume (m3) /year	Annual license fees (vatu)	Bankers guarantee (vatu)	Reforestation charge (vatu)
60-200	10,000	70,000	60,000
201-500	20,000	500,000	30% of log royalty

- (2) A production fee is not payable for any other mobile saw mill.”.

BY HIS LORDSHIP THE CHIEF JUSTICE



TO: THE ELECTORAL COMMISSION

The date appointed in the writ for the election of the President is Friday the 13th day of August 2004.



The closing time and date for the lodging of nominations is at 4.30pm on Sunday the 8th day of August 2004.


The election of the President shall take place at the Parliament House in Port Vila at 8.30am.



