## **THE HEALTH COMMITTEES ACT NO. 34 OF 2003**

An Act to establish health committees throughout Vanuatu and for related purposes.

Be it enacted by the President and Parliament as follows-

### **1 Definitions**

In this Act, unless the contrary intention appears:

**health area** means the area served by one or more health facilities.

**health committee** means a committee appointed under section 2.

**health facility** means a health centre, dispensary or aid post.

**health fees** means any consultation fee or fee payable for obtaining any medication at any health facility.

**Minister** means the Minister responsible for health.

**provincial health supervisor** means a provincial health supervisor appointed by the Ministry of Health to one of the 6 provinces in Vanuatu.

### **2 Appointment**

(1) A health committee is to be appointed for each health area by the provincial health supervisor of the province in which the health area is located.

(2) The appointments are to be made in writing.

### **3 Composition of each Committee**

(1) A health committee is to consist of 4 members.

(2) The members of the committee are:

(a) the head nurse of that health centre; and

- (b) a representative of the chiefs of the communities within the relevant health area; and
  - (c) a representative of the youths of the communities within the relevant health area; and
  - (d) a representative of the women in the communities within the relevant health area.
- (3) No allowances or other form of remuneration is payable to any member of the committee.
- (4) A member of the committee is to be appointed for a period of 2 years and can be reappointed.

#### **4 Meetings of the Committee**

- (1) A health committee is to meet at such times as are necessary for carrying out its functions under this Act.
- (2) The head nurse is to be the secretary for a health committee.
- (3) The committee is to determine and regulate its own procedures.

#### **5 Functions of the committee**

A health committee has the following functions:

- (a) to maintain each health facility within the relevant health area;
- (b) to charge and collect health fees;
- (c) to oversee the general sanitation of the communities within the relevant health area;
- (d) to use or spend money received by way of health fees for the overall maintenance of the health facilities and sanitation of the communities within the relevant health area;
- (e) to ensure that primary health care services are provided to the community.

#### **6 Powers of the committee**

A health committee has power to do all things that are necessary or convenient to be done for or in connection with the performance of its functions.

#### **7 Health Committees not to apply to hospitals**

Health committees are not to be appointed for hospitals.

## **8 Funds of the committee**

The funds of a health committee consist of:

- (a) money received by the committee by way of health fees; and
- (b) any other money received by the committee from any other source.

## **9 Misuse of funds of the committee**

A person must not misuse any funds of the committee.

Penalty: a fine not exceeding VT100,000 or a term of imprisonment of not more than one year, or both.

## **10 Distribution and accountability of health fees**

- (1) All health fees charged by a health facility are payable to the health committee responsible for that facility.
- (2) The provincial health supervisor in consultation with the head nurse of that facility must:
  - (a) check the receipt books; and
  - (b) balance the accounts.
- (3) The provincial health supervisor may remove a member from a health committee if that member misuses the funds of the health committee.
- (4) In carrying out his or her duties under subsection (2), the provincial health supervisor may seek assistance from the Ministry responsible for Finance.

## **11 Application of the Public Finance and Economic Management Act No. 6 of 1998**

The Public Finance and Economic Management Act No. 6 of 1998 does not apply to this Act.

## **12 Regulations**

- (1) The Minister may by regulation prescribe health fees required under this Act.
- (2) The Minister may make regulations necessary or convenient to be prescribed for carrying out or giving effect to this Act.

## **13 Commencement**

This Act commences on the date on which it is published in the Gazette.

### LOI NO. DE 2003 RELATIVE AUX COMITÉS DE LA SANTÉ

Prévoyant la création des comités de la santé à travers Vanuatu et à des fins connexes.

**Le Président de la République et le Parlement promulguent le texte suivant :**

#### 1 Définitions

Dans la présente Loi, sous réserve du contexte :

**comité de la santé** (*health committee*) désigne un comité établi conformément à l'article 2 ;

**droits médicaux** (*health fees*) désigne tout droit à tout établissement sanitaire ;

**établissement sanitaire** (*health facility*) désigne un centre médical, un dispensaire ou un poste de soin ;

**ministre** (*Minister*) désigne le ministre de la santé ;

**région sanitaire** (*health area*) désigne la région que dessert une ou des installations sanitaires ;

**superviseur provincial de la santé** (*provincial health supervisor*) désigne un superviseur provincial de la santé nommé par le ministre de la santé dans chacun des six conseils provinciaux de Vanuatu.

#### 2 Nomination

1) Un comité de la santé doit être établi dans chaque région sanitaire par le superviseur provincial de la santé de la province où se trouve la région sanitaire.

2) Les nominations sont faites par écrit.

#### 3 Nomination

1) Un comité de la santé comprend quatre membres.

2) Le comité est composé de :

- a) l'infirmier(ère) en chef de l'établissement sanitaire ;
- b) un représentant des chefs des localités de la région sanitaire ;
- c) un représentant des jeunes des localités de la région sanitaire ; et
- d) une représentante des femmes des localités de la région sanitaire.

- 3) Les membres du comité ne reçoivent aucune indemnité ou autre forme de rémunération.
- 4) Un membre du comité est nommé pour deux ans et sa nomination est renouvelable.

#### **4 Réunions du comité**

- 1) Un comité de la santé doit siéger aux moments nécessaires pour exécuter ses fonctions conformément à la présente Loi.
- 2) L'infirmier(ère) en chef est secrétaire du comité de la santé.
- 3) Le comité définit et réglemente ses propres procédures

#### **5 Fonctions du comité**

Un comité de la santé a pour fonctions de :

- a) entretenir chaque établissement sanitaire dans la région qu'il dessert ;
- b) imposer et percevoir les droits médicaux ;
- c) surveiller la santé générale des localités que couvre une région sanitaire ;
- d) utiliser ou dépenser l'argent reçu des droits médicaux dans l'entretien général des établissements sanitaires et la santé des localités que couvre la région sanitaire.
- e) s'assurer que les soins de premier recours sont dispensés à la population.

#### **6 Pouvoirs du comité**

Un comité de la santé a les pouvoirs de faire tout ce qui nécessaire ou qu'il convient de faire pour ou dans le cadre de l'exécution de ses fonctions.

#### **7 Comités de la santé ne concernent pas les hôpitaux**

Les comités de la santé ne doivent pas être établis pour les hôpitaux.

#### **8 Fonds du comité**

Les ressources financières du comité proviennent :

- a) des recettes des droits médicaux ; et
- b) de toute autre source.

#### **9 Détournement des fonds du comité**

Quiconque détourne les fonds du comité commet une infraction qui l'expose sur condamnation à une peine d'amende n'excédant pas 100.000 VT ou d'emprisonnement n'excédant pas un an ou les deux peines à la fois.

#### **10 Attribution et contrôle des droits médicaux**

- 1) Tous les droits médicaux imposés par l'établissement sanitaire sont versés au comité de la santé chargé de cet établissement.
- 2) Le superviseur provincial de la santé, en consultation avec l'infirmier(ère) en chef de l'établissement, doit :

- a) vérifier les livres des recettes ; et
  - b) équilibrer les comptes
- 3) Le superviseur provincial de la santé peut révoquer un membre d'un comité de la santé si celui-ci détourne les fonds du comité.
- 4) En exécutant ses fonctions conformément au paragraphe 2), le superviseur provincial de la santé peut demander l'aide du ministère des Finances.

**11 Application de la Loi No. 6 de 1998 relative aux finances publiques et à la gestion économique**

La Loi No. 6 de 1998 relative aux finances publiques et à la gestion économique ne s'applique pas à la présente Loi.

**12 Arrêtés**

- 1) Le ministre peut, par arrêté, prescrire les droits médicaux imposés conformément à la présente Loi.
- 2) Le ministre peut prendre des arrêtés nécessaires ou qu'il convient de prendre pour appliquer la présente Loi.

**13 Entrée en vigueur**

La présente Loi entre en vigueur à la date de sa publication au Journal officiel.






#### NOTICE OF AVIATION SECURITY SERVICE AND NAVIGATION INSTALLATION
