## **REPUBLIC OF VANUATU**

### **THE VANUATU MARITIME AUTHORITY (AMENDMENT) ACT NO. 2 OF 2004**

An Act to amend the Vanuatu Maritime Authority Act No. 29 of 1998.

Be it enacted by the President and Parliament as follows:-

#### **1      Amendments**

The Vanuatu Maritime Authority Act No. 29 of 1998 is amended as set out in the Schedule.

#### **2      Commencement**

This Act commences on the day on which it is published in the Gazette.

**1 Subsection 4(4)**

Repeal the subsection.

**2 Subsection 4(6) and (7)**

Repeal the subsections.

**3 Subsection 30(6)**

Delete “paragraph 4(2)(e)” substitute, “subsection 4(2)”.

**4 At the end of section 30**

Add

“(7) To avoid doubt, a member of the Authority referred to in subsection 4(2) who was appointed before the commencement of this Act, ceases by force of this subsection to be a member of the Authority if the Minister who appointed the member ceases to be a Minister”.





### **OFFICIAL OATH**






