


INSTRUMENT OF WITHDRAWAL OF FUNCTION FROM THE MINISTRY OF INTERNAL AFFAIRS


**INSTRUMENT OF WITHDRAWAL OF FUNCTION FROM

In exercise of the power conferred on me by subsection 9(2) of the Government Act No. 5 of 1998, I, Honourable HAM LINI VANUAROROA Prime Minister withdraw the functions of the Department of Strategic Management from the Ministry of Justice and Social Welfare and assign this function to the Prime Minister's Office.

INSTRUMENT OF DIRECTION OF RESPONSIBILITY FOR THE MINISTRY OF JUSTICE AND SOCIAL WELFARE

In exercise of the power conferred on me by subsection 9(2) of the Government Act No. 5 of 1998, I, Honourable HAM LINI VANUAROROA Prime Minister Direct that the Ministry of Justice and Social Welfare be responsible for the following Departments, Institutions and Programs:

- (a) Department of Correctional Services;
- (b) Department of Women's Affairs;
- (c) Judiciary;
- (d) Public Prosecutor's Office;
- (e) Public Solicitors Office;
- (f) Vanuatu National Council of Chiefs (Malvatumauri);
- (g) Legal Sector Programs;
- (h) Children's Programs;
- (i) Disability Programs.

This Instrument of Direction of Responsibility commences on the day on which it is published in the Gazette.
