## LAND LEASES (AMENDMENT) ACT NO. 5 OF 2007

An Act to amend the Land Leases Act [CAP 163].

Be it enacted by the President and Parliament as follows-

### **1 Amendment**

The Land Leases Act [CAP 163] is amended as set out in the Schedule.

### **2 Commencement**

This Act commences on the day on which it is published in the Gazette.

## SCHEDULE

### AMENDMENTS OF THE LAND LEASES ACT [CAP 163]

**1 Subsection 32B(4)**

Repeal the subsection substitute

“(4) A premium referred to in paragraph (3) (a) is to be determined based on the unimproved market value of the land at the date of the application.”

**2 Subsection 32C(6)**

Repeal the subsection, substitute

“(6) For the purposes of this section, the premium is to be calculated based on the full rental value of the unimproved value of the land and the annual contract rent as agreed to by the lessor and the lessee.”

**3 Subsection 32D(2)**

Repeal the subsection, substitute

“(2) A new lease is not to be issued unless the lessee or the registered proprietor pays to the lessor a premium based on the full rental value of the unimproved value of the land as determined by the Minister from time to time and the contract rent as agreed to by the lessor and the lessee.”

**4 At the end of section 32D**

Add

“(4) The Minister may by order, prescribe the full rental value of the different classes of leases which are to be reviewed every 5 years.”

**5 Subsection 48A(2)**

Repeal the subsection, substitute

“(2) If a proprietor of a registered lease sells that lease, the proprietor must pay to the lessor, not more than 10% of the difference in amount between the unimproved market value of the land at the time it was purchased and the unimproved market value of the land at the time of the present sale, unless the lessor and lessee have entered into other arrangements.”

**6 Section 50A**

Repeal the section.

### MODIFICATION DE LA LOI N°4 DE 1983 SUR LES BAUX FONCIERS

#### 1 Paragraphe 32B.4)

Supprimer et remplacer le paragraphe par

“4) Une prime citée à l’alinéa 3)a) doit être calculée en se basant sur la valeur marchande du terrain non améliorée à la date de la demande.”

#### 2 Paragraphe 32B.6)

Supprimer et remplacer par :

“6) Aux fins du présent article, la prime est calculée selon la valeur totale de location de la valeur non améliorée du terrain et le loyer annuel du bail convenu entre le bailleur et le preneur.”

#### 3 Paragraphe 32D.2)

Supprimer et remplacer par :

“2) Aucun nouveau bail ne doit être octroyé que si le preneur ou le propriétaire enregistré verse au ministre une prime selon la valeur totale de location de la valeur non améliorée du terrain déterminée par le ministre de temps à autre et le loyer du bail convenu entre le bailleur et le preneur.”

#### 4 À la fin de l’article 32D

Ajouter

“4) Le ministre peut par arrêté, prévoir la valeur totale des loyers des différentes catégories de baux qui doivent être révisés tous les cinq ans.”

#### 5 Paragraphe 48A.2)

Supprimer et remplacer par :

“2) Lorsqu’un propriétaire d’un bail enregistré vend ce bai, il doit verser au bailleur 10% du montant constituant la différence entre la valeur marchande non amélioré du terrain au moment de son achat et la valeur marchande non améliorée du terrain au moment de la vente actuelle sauf si le bailleur et le preneur ont conclu d’autres accords.”

#### 6 Article 50A

Supprimer l’article.
