**Seasonal Employment Agency Regulation**

**(Amendment) Order No. 30 of 2007**

In exercise of the powers conferred on me by section 77A of the Employment Act [CAP 160] and subsection 15(3) of the Interpretation Act [CAP 132], I, Honourable JOE NATUMAN, Minister of Internal Affairs, make the following Regulation:

**1 Amendment**

The Seasonal Employment Agency Regulation Order No.13 of 2007 is amended as set out in the Schedule.

**2 Commencement**

This Order commences on the day on which it is made.

## **SCHEDULE**

### **AMENDMENTS OF THE SEASONAL EMPLOYMENT AGENCY REGULATION ORDER NO. 13 OF 2007**

#### **1 Clause 11(2)**

Delete “has failed to comply with a provision of these Regulations.”, substitute “:

- (a) has records of involvement in scam or fraudulent activities; or
- (b) has had any previous convictions; or
- (c) has a record of overstay in a foreign country; or
- (d) has provided to him or her a false information in relation to the agent’s application for a licence under paragraph 65(2)(a) of the Act; or
- (e) has failed to comply with a provision of this Regulation.”




#### INSTRUMENT OF APPOINTMENT OF MEMBERS OF LABOUR ADVISORY BOARD
