ARRÊTE

1 Agent de correction temporaire relevant du Commissaire de la Police

En sus des dispositions du paragraphe 16.4) de la Loi, un agent de correction temporaire nommé conformément au paragraphe 16.1) de la Loi relève de la supervision du Commissaire de la Police dans l'exercice de ses fonctions à titre d'agent de correction.

2 Exercice des pouvoirs en vertu du paragraphe 16.4) de la Loi

Le Directeur et tout régisseur d'un centre correctionnel doit, dans l'exercice des pouvoirs que lui confère l'article 16.4) de la Loi, consulter le Commissaire de la Police sur toute question relative à l'exercice des fonctions d'un agent de correction temporaire conformément à la Loi.

3 Commissaire de la Police de capturer et ramener tout détenu au Centre Correctionnel

Le Commissaire de la Police doit s'assurer que tout détenu en évasion soit capturé et ramené au Centre correctionnel dans le bref délai possible.

4 Infraction à l'Arrêté

Toute omission de se conformer aux dispositions du présent Arrêté constitue une infraction grave.

5 Abrogation de l'Arrêté N°48 de 2006

L'Arrêté N° 48 de 2006 relatif au Règlement des Services Correctionnels sur la liberté provisoire est abrogé.

6 Durée du présent Arrêté

Le présent Arrêté entre en vigueur à la date de sa signature et devient caduc à la date de son abrogation.

LIQUOR LICENSING ACT [CAP 52]
Liquor Licensing (Prohibition of Sale)

Order No. 24 of 2008

To provide for a prohibition on the sale of liquor throughout Vanuatu.

In exercise of the powers conferred on me by section 19 of the Liquor Licensing Act [CAP 52] I, JOE NATUMAN, Minister of Internal Affairs, make the following Order:

1 Sale of Liquor prohibited

The sale of liquor in or from licensed premises through out Vanuatu whether for consumption on or off such premises is prohibited from 12 o'clock midnight on 1 September 2008 to 12 o'clock midday on 3 September 2008.


2 Exception

Liquor may be sold during the period referred to in section 1 within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with food.


3 Commencement


TEMPORARY PRACTICING CERTIFICATE PRACTICING CERTIFICATE NO.02 OF 2008

This is to certify that **PETER ANTHONY COOMBE** has been granted a Temporary Practicing Certificate for the purpose of appearing in the Courts of the Republic of Vanuatu on behalf of Bani Law of Port Vila, Efate in the Republic of Vanuatu.

This certificate is granted subject to the following conditions:

1. That the holder of this Certificate shall only act in the Republic of Vanuatu in conjunction with the Legal representation in Mutual Assistance Criminal Cases Nos. 03 of 2008, now known as Civil Case No.70 of 2008;
2. That the holder of this Certificate shall not engage in any legal work of any description other than legal work necessarily connected with the above matter;
3. That the holder of this Certificate, shall not hold himself out as a lawyer entitled to practice in Vanuatu other than in respect of the above matter, nor shall he accept any other brief from the said proceedings;
4. That the holder of this Certificate shall, during the subsistence of this Certificate, ensure that he has complied with all relevant laws of Vanuatu relating to the residence and employment of non-citizens;
5. That this Certificate shall cease to have effect upon the conclusion of the abovenamed matter.
