### LIQUOR LICENCING ACT [CAP 52]

#### Liquor Licensing (Prohibition of Sale)

Order No. 49 of 2008

In exercise of the powers conferred on me by section 19 of the Liquor Licensing Act [CAP 52], I, the Honourable PATRICK CROWBY MANAREWO, Minister of Internal Affairs, make the following Order.

#### 1 Sale of Liquor Prohibited

The sale of liquor in or from licensed premises throughout the provinces of PENAMA, MALAMPA, SHEFA and TAFEA whether for consumption on or off such premises is prohibited from 12 midnight Monday 1st December 2008, to 12 midday Thursday 4<sup>th</sup> December 2008.

#### 2 Exemption

Liquor may be sold during the period referred to in section 1 within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with food.

#### 2 Commencement

This Order commences on the day on which it is made.






