


FOREIGN SERVICE ACT NO. 22 OF 2008

Instrument of Appointment – Ambassador of Vanuatu Order No. 51 of 2009





OFFICIAL SECRETS ACT [CAP 111]

DECLARATION BY PERSON HOLDING OFFICE IN THE SERVICE OF THE GOVERNMENT OF THE REPUBLIC OF VANUATU

I TAPANGARARUA WILLIE JIMMY being the Ambassador Extraordinary and Plenipotentiary of the Republic of Vanuatu to the Peoples Republic of China, hereby declare that the provisions of the Official Secrets Act [CAP 111] and in particular section 2 thereof and the definition of classified material contained therein, have been brought to my attention, and I understand the same and that I am fully aware of the serious consequences which may follow any breach of those provisions.

I further understand that I am liable to be prosecuted for an offence under the Act whether committed during the tenure of my present office, or any other office I might hold, in the service of the Government or committed after I cease to hold office in the service of the Government.
