

FISHERIES ACT [CAP 315]

Implementation of access or related Agreements (Transitional Arrangements)

Order No. 38 of 2010

In exercise of the powers conferred on me by section 79 of the Fisheries Act [CAP 315] with particular reference to subsection 79 (2)(u) of the same Act, I, **STEVEN KALSAKAU**, Minister for Agriculture, Quarantine, Forestry & Fisheries, hereby make the following order:

1. Interpretation

“access agreement” means a treaty, agreement or arrangement to which section 7 of the Act applies and also means any agreements applying under the repealed Act and having application under the Act;

“Act” means Fisheries Act [CAP 315] and any regulation or other subordinate legislation made under that Act;

“Director” means the person holding the office of Director of Fisheries from time to time;

“Minister” means the Minister responsible for fisheries;

“the repealed Act” means the Fisheries Act [Cap. 158] which was in force immediately before its repeal by the Fisheries Act [CAP 315];

2. Continuation of Application of Access Agreements under the repealed Act

(1) Any access or related agreement entered into by the Minister of Fisheries acting within its powers and duties under the repealed Act continues to have effect and application under the Act.

(2) Any access or related agreement entered into by the Minister of Fisheries acting within its powers and duties under the repealed Act continues to be binding on the parties which have executed that agreement.

(3) This order is been made pursuant to section 82 (6) of the Act and ensures that any access or related agreement made under the repealed Act has continuous application even after the coming into force of the Act and any approvals, permits, arrangements or directives made pursuant to those access or related agreements are saved under the Act pursuant to section 82 (6) of the Act.

3. Continuation of Terms and Conditions of Access Agreements

- (1) The terms and conditions of any access or related agreement, mentioned in section 2 of this Order, shall continue to have application and effect over any fisheries related activities being carried out to date by virtue of that access or related agreement.
- (2) Any fisheries related activities being carried out pursuant to the terms and conditions of any access or related agreement, mentioned in section 2 of this Order, shall be maintained by the parties in the agreement unless otherwise varied by the parties within the terms of the access or related agreement.
- (3) Specific terms and conditions of any access or related agreement, mentioned in section 2 of this Order, relating to Fees and Charges payable to the Government shall be maintained by the parties in the agreement unless otherwise varied by the parties within the terms of the access or related agreement.

4. Amendments to this Order

- (1) This Order may be amended, revoked or varied by the Minister for Fisheries, after proper consultations with the persons named as parties in the access or related agreement, mentioned in section 2 of this Order, and having obtained a written consent from those persons.
- (2) The Minister in amending, revoking or varying this Order, must also consult with the Director.

5. Commencement

This Order commences on the date upon which it is made.

HONOURS ACT [CAP 120]

30TH INDEPENDENCE ANNIVERSARY MEDAL

Order No. 39 of 2010

In exercise of the powers conferred on me by paragraph 1(1) (e) of the Honours Act [CAP 120], I, IOLU JOHNSON ABBIL KANIAPNIN, President of the Republic of Vanuatu, make the following Order.

1 30th Independence Anniversary Medal

A medal known as the “30th Independence Anniversary Medal” (the “medal”) is instituted for the purpose of giving recognition to persons to mark the thirtieth anniversary of the Independence of Vanuatu.

2 Award of the Medal

- (1) The medal is to be awarded to mark the thirtieth Anniversary of the Independence of the Republic of Vanuatu which is an historical event and which is a significant milestone in Vanuatu’s history as an Independent nation.
- (2) The medal is limited to an issue of 300.
- (3) The medal may be awarded to:
 - (a) Head of States and other foreign dignitaries who are invited to attend the 30th Independence celebrations of Independence of the Republic of Vanuatu; or
 - (b) persons holding certain offices; or
 - (c) persons who have contributed with distinction to the maintenance of an independent Vanuatu.
- (5) The names of the persons to whom the medal is to be awarded shall be published in the Gazette.

3 Form of Medal

The Medal is to:

- (a) be cast metal, polished silver colour and suspended by a ribbon bar; and
- (b) be circular in shape with a diameter of 36 millimetres; and
- (c) have a raised edge circumference on both the Obverse and Reverse; and
- (d) bear on the front :
 - (i) a relief of the picture of the statue a father, son and a mother holding a baby which is at the entrance of the National Parliament of Vanuatu, surrounded by the words “RIPABLIK BLONG VANUATU 30 YIA INDIPENDENS ANIVERSERI”; and
 - (ii) at the bottom of the picture of the statue referred to in subparagraph (i), the word “MATURITI”; and
- (e) bear on the back in relief the Vanuatu Coat of Arms with the dates “1980” and “2010” on either side of the Coat of Arms; and
- (f) be suspended from a circular ring on a ribbon, 32 mm wide, consisting of 7 bands of colours as specified in the Schedule.

4 Register of Awards

The Registrar of Honours and Awards shall maintain a Register of names of the persons who have been awarded the 30th Independence Anniversary Medal and keep such other records relating to the award of this medal as the President may direct.

5 Commencement

This Order commences on the day on which it is made.




(a) Front and Back details of the medal



(b) Ribbon


Details of the colours of the ribbon and their sizes from left to right:

- (vii) Red, 6 millimetres.




(c) Detail picture of the medal
