INSTRUMENT OF DECLARATION

I, Mr. Joe Natuman, Minister for Foreign Affairs.


HEREBY DECLARE that the Government of the Republic of Vanuatu makes the following declaration to accede to the Constitution of the Asia Pacific Telecommunity under paragraph 2 of Article 3 and Article 19 of the Constitution which provides that :

Membership in the Telecommunity shall be open to any State within the region which is a member of ESCAP. Any such State on becoming a party to this Constitution in accordance with the provisions of Article 17 or Article 19 shall become a Member of the Telecommunity.

That the Government of the Republic of Vanuatu has declared its full commitment in meeting all obligations under the Constitution of the Asia Pacific Telecommunity and in recognition of this commitment, and accepts all the articles of the Constitution.

CONSTITUTION OF THE ASIA PACIFIC TELECOMMUNITY

This Note is the Instrument of Accession of the Government of the Republic of Vanuatu to the Asia-Pacific Telecommunity and will be deposited with your Excellency, Mr. Secretary-General, in conformity with Article 19 of the Constitution.




