In exercise of the powers conferred on me by section 19 of the Ports Act [CAP 26], I, Capt. LUC BEANDI, Harbourmaster, make the following Order.

1 Removal of MV Percy Jean

- (1) Neil SLATER or his agent must do the necessary with urgency to remove the MV Percy Jean from under the waters at Lenakel Port.
- (2) The removal of MV Percy Jean under subclause (1) must be carried out within one month of the date of this order.

2 Disposal of MV Percy Jean

Neil SLATER or his agent must liaise with the following departments when making necessary arrangement for the disposal of MV Percy Jean, the:

- (a) Department of Ports and Harbour; and
- (b) Environment Unit Department; and
- (c) Fisheries Department.

3 Commencement
