1 Withdrawal of functions from the Prime Minister's Office

The function of being responsible for Air Vanuatu Limited is withdrawn from the Office of the Prime Minister.

2 Assignment of functions to the Ministry of Infrastructure and Public Utilities

The function withdrawn from the Office of the Prime Minister under clause 1 is assigned to the Ministry of Infrastructure and Public Utilities.

3 Commencement
