## REPUBLIC OF VANUATU

### FISHERIES ACT [CAP 315]

#### **Fisheries Regulations Order No. 111 of 2012**

To provide for an exception to the Fisheries Regulations Order No 28 of 2009 for the purposes of the Torba Provincial Games.


In exercise of the powers conferred on me by subsection 79(1) of the Fisheries Act [CAP 315], I, the Honourable JAMES NGWANGO Minister of Agriculture, Quarantine, Fisheries and Forestry make the following Order.

- 1 Exception to subclause 67(1) of the Fisheries Regulation Order 28 of 2009**
  - (1) Coconut crabs may be harvested during the period commencing on 1<sup>st</sup> September and ending on 8<sup>th</sup> September 2012 for consumption purposes only during the Torba Provincial games.
  - (2) The total number of coconut crabs to be harvested must not exceed 500.
  - (3) A person is allowed to sell coconut crabs at the game premises only.
  
- 2 Exportation of coconut crabs out of Torba Province**
  - (1) A person must not export coconut crabs out of Torba Province during the period specified under clause 1.
  - (2) A person commits an offence and is subject to the penalty specified under clause 79 of the Fisheries Regulation Order No 28 of 2009, if the person fails to comply with subclause (1).

**3 Commencement**

This Order commences on the day on which it is made.



#### 3 Appointment of members to the Board of Arbitration




