Declaration of Polling Day Order No. 60 of 2012

In exercise of the powers conferred on me by section 21 of the Representation of the People Act [CAP 146] and acting on the advice of the Prime Minister given after consultation with the Electoral Commission and the Principal Electoral Officer, I, His Excellency IOLU JOHNSON ABBIL, President of the Republic of Vanuatu, fix Tuesday 30th October 2012 to be the polling day for the purposes of the general election of Vanuatu.


PUBLIC HOLIDAYS ACT [CAP 114]

In exercise of the powers conferred on me by section 2 of the Public Holidays Act [CAP 114] and acting on the advice of the Prime Minister, I, His Excellency IOLU JOHNSON ABBIL, President of the Republic of Vanuatu, declare Tuesday 30th October 2012 to be a public holiday for all citizens of Vanuatu working and residing throughout Vanuatu for the purposes of the general election of Vanuatu.
