1 Official Gazette annual subscription fees

- (1) The annual subscription fee for the electronic copies of the Official Gazette is VT 28,125 (VAT inclusive).
- (2) The annual subscription fee for hard copies of the Official Gazette is VT 35,000 (VAT inclusive).
- (3) The annual subscription fee for both hard and electronic copies of the Official Gazette is VT 63, 125 (VAT inclusive).

2 Charge for a copy of any electronic document

The fee for a copy of any electronic document is VT 500 plus VAT.

3 Rates for copies of documents banded

- (1) The rates for copies of documents banded are:
 - (a) Band A (1 to 5 pages) VT 500 + VAT;
 - (b) Band B (6 to 9 pages) VT 800 + VAT;
 - (c) Band C (10 to 25 pages) VT 1,400 + VAT;
 - (d) Band D (26 to 49 pages) VT 2,200 + VAT;
 - (e) Band E (50 to 75 pages) VT 3,200 + VAT.

The fee for the electronic and hard copy of the Laws of the Republic of Vanuatu (Consolidated edition 2006) is VT 70,000.

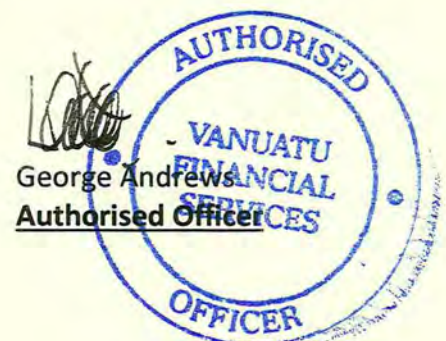

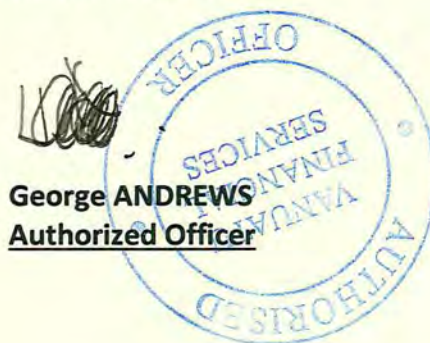
