1 2013 Sandalwood harvesting season

The sandalwood harvesting season is to commence on 08 July 2013 and ends on 07 October 2013 for the following islands:

- (c) Efate;

- (f) Aniwa
- (g) Futuna;
- (h) Aneityum.

2 Licence quota

The licence quota for the 2013 sandalwood harvesting season is not more than 82 metric tons.

3 Prices for various grades of sandalwood

The minimum prices for the various grades of sandalwood heartwood are set as follows:

- (a) 1st grade heartwood – VT4000 per kilogram;
- (b) 2nd grade heartwood – VT3000 per kilogram;
- (c) 3rd grade heartwood – VT2000 per kilogram.




