TOURISM COUNCILS ACT NO. 23 OF 2012

Provincial Government Tourism Council Sitting Allowance Order No. 4 of 2014

In exercise of the powers conferred on me by subsections 19 (1) and (2) of the Tourism Councils Act No. 23 of 2012, I, the Honourable TOARA DANIEL KALO, Minister of Tourism, Trade, Commerce and Ni-Vanuatu Business make the following Order.

1 Sitting Allowance

Subject to clause 2, the amount of sitting allowances payable to each member of a Provincial Government Tourism Council is VT5,000 for each day on which a council sits for a meeting.

2 Provincial Government Tourism Councils entitled to sitting allowances


A member of the following Provincial Government Tourism Councils is entitled to a sitting allowance referred to in clause 1:

- (a) the Tafea Tourism Council; and
- (b) the Shefa Tourism Council; and
- (c) the Sanma Tourism Council; and
- (d) the Malampa Tourism Council; and
- (e) the Penama Tourism Council; and
- (f) the Torba Tourism Council.

2. Commencement

This Order commences on the day on which it is made.

VT1 AND VT2 COINS and VT100 BANKNOTE

NOTICE NO. 2 OF 2014

In exercise of its powers under Section 20(4) of the Reserve Bank of Vanuatu Act (CAP 125), the Bank has decided to demonetize the VT1 and VT2 coins and the VT100 banknote effective, **28 February 2014**. This means that from that date, these Vatu denominations will no longer be legal tender and shops and cash handlers need not accept them for purchases of goods and services.

The Bank stopped issuing VT1 and VT2 coins from 31 March 2011 and the VT100 banknote was replaced with a coin of the same monetary value in August 1988. These notes and coins are being used less frequently by the communities but can cause inefficiencies for shops and cash handlers.

The Bank appeals and encourages the general public to check out their holdings of these Vatu denominations and deposit or exchange them for higher value denominations with commercial banks, spend them in shops or donate them to charities, prior to the deadline of 28 February 2014.

From 28 February 2014 the VT1, VT2 coins and VT100 banknote will only be redeemable at the Reserve Bank of Vanuatu in Port Vila.

LES PIÈCES DE VT1 ET VT2 et LE BILLET DE VT100

NOTICE NO. 2 OF 2014

En vertu de la section 20(4) de l'Acte de la Banque de Réserve de Vanuatu (CAP 125), la Banque a décidé de démonétiser les pièces de VT1 et VT2 et les billets de VT100 effectif au **28 Février 2014**. Cela signifie qu'à partir de cette date, ces dénominations n'auront plus de cours légal et que les magasins et institutions financières traitant avec ces derniers ne les accepteront plus pour les achats des biens et services.

La Banque a arrêté d'émettre les pièces de VT1 et VT2 à partir du 31 Mars 2011 et le billet de VT100 a été remplacé par une pièce de même valeur monétaire en Août 1988. Ces pièces et billets ont été utilisées moins fréquemment mais pourraient être sources d'inefficacité pour les magasins et les professionnels.

La Banque incite et encourage le public à vérifier leurs avoirs ayant ces dénominations et les déposer ou les échanger contre des dénominations supérieures dans les banques commerciales, à les dépenser dans les magasins ou les donner à des oeuvres charites, avant la date limite du 28 Février 2014.

A partir du 28 Février 2014, les pièces de VT1, VT2 et le billet de VT100 ne seront échangés qu'à la Banque de Réserve à Port Vila.






