BY-LAW

No . 1 of 2013

OVERSEAS CRUISE SHIP TAX

ARRANGMENT OF SECTIONS

SECTION

1. Interpretation
2. Tax on Ports

EXPLANATORY NOTE

- The purpose of this By-Law is to make provisions for payment of a levy or tax for Ports Due at Tafea Local Government Council.
- This By-Law is made pursuant to section 20, 21 and 22 of the Decentralization Act [CAP. 230] (“the Act”).
- The purpose of this By-Law is to raise revenue for the Tafea Local Government Council.
- Under Section 21 of the Act, the Council may legislate By-Laws providing for fixing of rates and taxes for issues of Licenses or other charges on matters in respect of which there are already existing taxes provided that the rate prescribed does not exceed 10% of the existing amount. There is also the requirement that such a By-Law would require the specific endorsement of the Minister of Internal Affairs and that Minister has consulted with the Minister of Finance.

INTERPRETATION

1. In this By-Law, unless the context otherwise require:

“Act” mean the Decentralization Act [CAP. 230] including any amendments thereof.

“Council” means the Tafea Local Government Council established under the Act of Tafea Local Government Region.

“Officer” means an officer or employee or agent engaged by the Council.

“TAFEA” means all the islands comprising Tafea Local Government Region.

“Overseas Cruise Ship” means cruise ships **ONLY** and not any other vessel transporting tourist to Tafea for holiday.

“Service Providers” means all the owners or agents of Businesses registered and defined under the Business License Act [CAP. 249] and conducting business within Tafea Local Government Region.

“Shipping Agent” means any registered company in Vanuatu which deals with foreign shipping companies including Cruise ships.

TAX OF CRUISE SHIP

- 2.(1) There shall be a tax on cruise ship including but not limited to P&O Ships berthing or anchoring in any bay or wharf at any island in Tafea;
- (2) All shipping agents are required to make declaration to the Tafea Local Government council by providing the list of name of ship, capacity and date of call to each port of call within Tafea Local Government Council.
- (3) In cases of urgent call due to unforeseen circumstances, all shipping agents should at least inform the Tafea Local Government Council before the visit or after the visit.

EXCEMPTION

- 3.(1) Provided that no such tax shall be payable in respect of:
 - (a) Any organization that is operating outside the provisions of the Business Licenses Act or exempted by the Business License Act;

- (b) Any business or organization engaged in humanitarian or search and rescue operation; charitable organization; and
- (c) Any use for the Military, diplomatic or ceremonial purposes of the government for promotion of the Country's interest.

AMOUNT OF TAX TO BE LEVIED

- 4. (1) The amount of tax hereby prescribed shall be variable as follow depending on the ship capacity:
 - (a) 50, 000vt per call with a cruise capacity of 1,000 or more passengers;
 - (b) 25, 000vt per call with a cruise capacity of 500 to less than 1,000 passengers;
 - (c) 15,000vt per call with a cruise capacity of less than 500 passengers.

METHOD OF PAYMENT

- 5. (1) Unless otherwise specified, the **ports due fee** shall be paid to the Tafea Local Government Council,
- (2) Immediately after the ship had left the port, the Tafea Local Government council shall invoice the relevant Shipping Agent giving it a 15 days time period to make the payment to the Tafea Local Government Council bank account,
- (3) If the ports due is not paid by the Shipping Agency concern to the Council, and unless a waiver is granted, there shall be a penalty fee of 100% surcharge of default in payment imposed by the Tafea Local Government Council.
- (4) The Tafea Local Government Council may recover the amount of tax and penalty due as a civil debt.

ARRANGEMENT FOR COLLECTION OF TAX

- The Council may after consultation with the Minister of Internal Affairs and Minister of Finance issue written instructions to all Shipping Agencies as to the payment and collection of the tax.

COMMENCEMENT DATE

- This By-Law shall come into force on the day of its publication in the official Gazette.


