TRADE DISPUTES ACT [CAP 162]

Deferral of Industrial Action Order No. 142 of 2015

In exercise of the powers conferred on me by subsection 34(1) of the Trade Disputes Act [CAP 162], I, the Honourable HOSEA NEVU, Minister of Internal Affairs, make the following Order.

1 Industry and undertaking

The following institutions have undertaken to engage in industrial action as of 21 October 2015, subject to the settlement of their demands:

- (a) Airports Vanuatu Limited; and
- (b) Vanuatu National Workers Union.

2 Deferral of Industrial Action

During the period for which this Order remains in force, a person or class of persons specified under clause 2 must not:

- (a) call, organise, procure or finance a strike or any irregular industrial action or threaten to do so; or
- (b) institute, carry on, organise, procure or finance a lock-out or threaten to do so.

3 Application of Order

This Order applies to the following persons and classes of persons:



- (b) Ephraim Kalsakau, General Secretary of the Vanuatu National Worker's Union;
- (c) Jason Rakau, Union Representative;
- (d) all staff of the Airports Vanuatu Limited and their relatives;
- (e) members of the General Public.

4 Commencement

This Order commences on the day on which it is made and ceases to have effect after 60 days from the date of commencement of this Order.
