AN ACT to repeal the Cocoa Acts and to dissolve the
Cocoa Board.

BE IT ENACTED by the Legislative Assembly of Western
Samoa in Parliament assembled as follows:-

1. Short Title and commencement - (1) This Act may be cited as the Cocoa Acts Repeal Act 1990.
(2) This Act shall come into force on such date as shall be specified by the Head of State by Order.

2. Interpretation - "The Cocoa Board" means the Cocoa Board continued under the Cocoa Act 1981 and intended to be continued under the Cocoa Act 1988.

3. Dissolution of Cocoa Board (1) The Cocoa Board is dissolved and all of its assets real or personal and subject to the provisions of clause 4 of this Act all of its liabilities are vested in and assumed by the Government.

(2) All assets so vested shall be realised and the proceeds of the realisation shall be applied in satisfaction or partial satisfaction of the liabilities referred to in subsection (1) of this section. If such proceeds are insufficient to satisfy such liabilities in full, the residue shall be satisfied by payment from the Treasury Fund as statutory expenditure.

4. No liability for loss of contract - (1) Subject to subsections (2) and (3) of this section, on the coming into force of this Act all continuing contracts shall cease to exist.

(2) Notwithstanding the provisions of subsection (1) of this section, every lease previously entered into by the Cocoa Board and every option to purchase previously granted to the Cocoa Board for the purchase of any land or interest in land shall continue to exist and the interest of the Cocoa Board in such leases and options together with the liabilities thereunder shall by this Act vest in or become liabilities of the Government.

(3) Nothing in subsection (1) of this section shall apply to any indebtedness of the Cocoa Board existing at the date of the coming into force of this Act or to any subsequent

interest payable in respect of such indebtedness.

(4) Notwithstanding anything to the contrary expressed or implied in paragraph (c) of Section 19 of the Acts Interpretation Act 1974 or any other portion of that Act no person shall be entitled to any compensation as a result of the determination of any contract consequent upon or arising out of the dissolution of the Cocoa Board or consequent upon or arising out of any other provision of this Act.

5. Repeals and revocations - (1) The Acts referred to in the First Schedule to this Act are repealed.

(2) The regulations referred to in the Second Schedule to this Act are revoked.

(3) All orders, warrants, appointments, regulations and generally all acts of authority which originated under any of the enactments repealed or regulations revoked by this Act which are subsisting at the coming into force of this Act are revoked.

6. Savings - (1) All actions, matters and proceedings commenced under any of the enactments repealed by this Act and which are pending or in progress at the date that this Act comes into force, may be continued, completed and enforced under this Act by or against the Government as if the Government were the Cocoa Board.

(2) The Cocoa, Copra and Produce Inspection Fees Regulations 1983 shall by virtue of the Produce Export Ordinance 1961 continue in force.

7. Act to bind Government - This Act shall bind the Government.
