

THE GENERAL LAWS (NO. 3) ORDINANCE, 1933

AN ORDINANCE

made by the Administrator of the Territory of Western Samoa with the advice and consent of the Legislative Council of that Territory, and in pursuance of the Samoa Act, 1921.

1. The provisions of 'The Cocoa Beans Sales Ordinance, 1931', shall have no application force or effect in the island of Savaii. The Cocoa Beans Sales Ordinance, 1931.

2. (1) Section 12 of 'The Arms Ordinance, 1921', is hereby amended by adding thereto the following:— The Arms Ordinance, 1921.

“(6) No fees shall be payable for permits issued under this section to purchase any explosive.

(7) A current license for any gun or offensive weapon may be transferred from one person to another person on payment of a fee of five shillings for such transfer which shall be endorsed on the license and signed by the Chief Arms Officer.

(8) Notwithstanding anything to the contrary contained elsewhere in this Ordinance a person arriving in Samoa and being in possession of a gun or offensive weapon may in the discretion of the Chief Arms Officer be granted a permit to import such gun or offensive weapon, and a fee of five shillings shall be payable for such permit.”

(2) Section 40 and the Second Schedule of 'The Arms Ordinance, 1921' shall be read subject to the provisions of the foregoing sub-section.

3. (1) Sub-section (1) of Section 6 of 'The Road Traffic Ordinance, 1931', is hereby amended by deleting all words after the words "(hereinafter referred to as 'registration plates')" and substituting the following words therefor:

"which shall be of such design, numbers, distinguishing marks, and colours as shall be prescribed, issued and sold by the Registrar annually."

(2) Sub-section (2) of Section 18 of 'The Road Traffic Ordinance, 1931', is hereby amended by adding the words "completely useless or" between the words "be" and "exported" in first line thereof.

4. Sections 4 and 5 of 'The Fugalei Street and Building Alignment Ordinance Amendment Ordinance, 1931,' shall be deemed to have been repealed as from the tenth day of October, 1932. (the date of the coming into operation of 'The Building Alignment Ordinance, 1932').
