AN ACT to amend the Head of State Act 1973.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. **Short Title and commencement** - (1) This Act may be cited as the Head of State Amendment Act 1992/1993 and shall be read together with and deemed part of the Head of State Act 1965 (hereinafter referred to as the principal Act).
(2) This Act with the exception of subsection (2) of section 2 shall commence on the date

upon which it is assented to by the Head of State.

(3) Subsection (2) of section 2 of this Act shall be deemed to have commenced on the 31st day of December 1990.

2. Remuneration of Council of Deputies - (1) Subsection (1) of section 16 of the principal Act is amended by adding a new paragraph as follows :-

" (d) As from the 1st day of January 1990, a special taxable allowance calculated at the rate of \$3,000 per annum.

(2) Section 16 of the principal Act is further amended by inserting after immediately subsection (1) the following new subsection:-

" (1A) When and so often as there occurs a general wage and salary increase for Public Servants by which wages and salaries of Public Servants are increased by a fixed percentage the salary of the Council of Deputies shall by authority of this Act be increased by a like percentage."

(3) Section 16 of the principal Act is further amended by omitting from subsection (2) the words "or personal expense allowance" and substituting the words "allowance or refund".

3. Official residence for Council of Deputies - Section 16B of the principal Act is repealed and the following section is substituted:-

"**16B Official residence for Council of Deputies** - (1) The Government may provide each or any Member of the Council of Deputies with an official residence, appropriate to the dignity of his position, free of charge, together with such furniture, floor coverings, soft furnishings and necessary household articles to be approved from time to time by the Head of State acting on the advice of Cabinet.

(2) Whenever the Government does not provide a member of the Council of Deputies with an official residence there shall be paid to that Member from the Treasury Fund as statutory expenditure a tax exempt housing allowance, a sum

calculated at the rate of \$3000 per annum.

(3) Subsection (2) of this section shall be deemed to have come into effect upon the 1st day of January 1990."

UA FAIA e le Fono Aoao Faitulafono a Samoa i Sisifo i totonu o le Palemene ua potopoto e faapea:-

1. **Igoa Puupuu ma le Amataga** - (1) E mafai ona taua lenei Tulafono o Teuteuga o le Tulafono o le Ao o le Malo 1992/1993 ma e tatau ona fai tauina faatasi ma avea ai o se vaega o le Tulafono o le Ao o le Malo 1965 (e pei ona faasinomia mulimuli ane iinei o le Tulafono autu).

(2) O lenei Tulafono ae vagana ai le faafuaiupu (2) o le fuaiupu 2 e tatau ona amata faamamaluina i le aso o le a tuuina i ai le maliega a le Ao o le Malo.

(3) O le Faafuaiupu (2) o le fuaiupu 2 o lenei Tulafono e tatau ona avea e faapea na amataina i le aso 31 o Tesema 1990.

2. Totogi o le Sui o le Fono o Sui Tofia - (1) O le Faafuaiupu (1) o le fuaiupu 16 o le Tulafono autu ua teuteuina i le faaopoopoina i ai o se parakalafa fou e faapea:-

"(d) E amata mai i le aso 1 o Ianuari 1990, se alauni faapitoa e tuusaunoa mai i lafoga ua fuafuaina i le sua faatatau e \$3,000 i le tausaga."

(2) O le Fuaiupu 16 o le Tulafono autu ua toe teuteuina i le faaofiina i ai ina ua tuanai le faafuaiupu (1) le faafuaiupu fou e faapea:-

"(1A) I le taimi ma taimi uma o le a tulai mai ai se siitaga aoao i totogi ma togioso o le Aufaigaluega a le Malo ma o ia totogi ma togioso ua siiina i se pasene faatulagaina, o totogi o Sui o le Fono o Sui Tofia e tatau ona siiina i se pasene tutusa i luga o le Pule a lenei Tulafono."

(3) O le Fuaiupu 16 o le Tulafono autu ua toe teuteuina i le aveeseina mai le faafuaiupu

(2) ia upu "po o alauni o tupe faaalu e le tagata" ma ia suia i upu "alauni po o tupe toe totogi atu".

3. Maota o le Malo e alaala ai Sui o le Fono o Sui Tofia- O le Fuaiupu 16B o le Tulafono autu ua soloia ma ua suia i le fuaiupu e faapea:-

"16B Maota o le Malo e alaala ai Sui o le Fono o sui Tofia - (1) E mafai e le Malo ona tuuina atu i Sui taitasi po o so o se Sui O le Fono o Sui Tofia se maota o le malo e alaala ai, e talafeagai ma le mamalu o lona tofi, e aunoa ma se totogi, faatasi ai ma ni meafale, mea fola fale, isi mea faapena ma oloa tau fale o le a faamaonia mai i lea taimi i lea taimi e le Ao o le Malo i luga o le fautuaga a le Kabeneta."

(2) I so o se taimi e le tuuina atu ai e le Malo i se sui o le Fono o Sui Tofia se maota o le malo e alaala e tatau ona totogiina atu i lena sui mai i Faaputuga-tupe a le Matagaluega o Tupe e avea ai ma tupe alu faale-tulafono o alauni mo fale e tuusaunoaina mai i lafoga, i se vaega-tupe ua fuafuaina i le sua faatatau e \$3,000 i le tausaga.

(3) O le Faafuaiupu (2) o lenei fuaiupu e tatau ona faapea na amata faamamaluina i le aso 1 o Ianuari 1990."
