**AN ACT authorising the Government to borrow the sum of one hundred and twenty-five thousand tālā from the Bank of New Zealand, and the borrowing in Western Samoa of a sum not exceeding one million tālā, and the borrowing in New Zealand of a sum not exceeding one million New Zealand dollars.**

**BE IT ENACTED** by the Legislative Assembly of Western Samoa in Parliament assembled as follows:—

**1. Short title**—This Act may be cited as the Loan Authorisation Act (No. 2) 1975. [23 December 1975]

**2. Authorising the borrowing of WS\$125,000 from the Bank of New Zealand**—WHEREAS the present capital of the Bank of Western Samoa constituted by the Bank of Western Samoa Ordinance 1959 is seven hundred and fifty thousand tālā divided into three thousand seven hundred and fifty shares of two hundred tālā each and held by the Bank of New Zealand and the Government of Western Samoa in equal proportion AND WHEREAS the proprietors of the Bank of Western Samoa consider it desirable to increase the capital of the Bank of Western Samoa and therefore propose to resolve to increase such capital to one million tala by the creation of one thousand two hundred and fifty new shares of two hundred tālā each, to rank pari passu in all respects with existing shares in the capital of the Bank

of Western Samoa and to be subscribed for by the proprietors in equal proportions, namely, six hundred and twenty-five new shares by the Bank of New Zealand and six hundred and twenty-five new shares by the Government of Western Samoa AND WHEREAS the proprietors propose that the new shares shall be issued at par and shall be paid for as at the 31st day of December 1975 AND WHEREAS the Bank of New Zealand has offered to lend to the Government of Western Samoa the sum necessary to enable the Government of Western Samoa to subscribe for its new shares, being one hundred and twenty-five thousand tālā AND WHEREAS the loan is to bear interest from the date of advance until repayment AND WHEREAS the interest is to be at a rate per annum equivalent to the divided rate of the Bank of Western Samoa (declared from time to time in respect of each year's operations) so long as that dividend rate is between four and eight per centum per annum AND WHEREAS so long as that dividend rate is below four per centum or no dividend is declared in respect of any year the interest on the loan is to be at a rate of four per centum per annum AND WHEREAS so long as that dividend rate is above eight per centum per annum the interest on the loan is to be at a rate of eight per centum per annum AND WHEREAS the loan is to be repayable with the interest over a term of ten years from the date of advance on an amortization basis, in half-yearly instalments, and with the principal portions of those instalments to be calculated as if the rate of interest on the loan were invariable at five per centum per annum AND WHEREAS the Government of Western Samoa is nevertheless to have the right to repay the loan or any part of it at any time during the term of ten years without notice, whereupon interest would cease to be payable on the principal so repaid, and the amortization basis for any principal not repaid would be adjusted by mutual agreement between the parties AND WHEREAS the loan is to be secured by an issue to the Bank of New Zealand of stock of the Government of Western Samoa of a face value equivalent to the amount of the loan BE IT THEREFORE ENACTED AS FOLLOWS:—

The Government of Western Samoa is hereby authorised to borrow from the Bank of New Zealand the sum of one hundred and twenty-five thousand tālā on the terms recited in this section.

**3. Authorising the borrowing of WS\$1,000,000 in Western Samoa**—The Minister of Finance is hereby authorised, subject to the provisions of the Financial Powers Act 1964, to borrow on the security of the public revenues of Western Samoa, during the year ending with the 31st day of December 1976, a sum of money not exceeding one million tālā, the stock being issued and registered in Western Samoa, and repayable in Western Samoa over a term or terms not exceeding 20 years each.

**4. Authorising the borrowing of NZ\$1,000,000 in New Zealand**—The Minister of Finance is hereby authorised, subject to the provisions of the Financial Powers Act 1964, to borrow on the security of the public revenues of Western Samoa, during the period ending with the 31st day of December 1976, a sum of money not exceeding one million New Zealand dollars, the stock being issued and registered in New Zealand, and repayable in New Zealand currency over a term or terms not exceeding 25 years each.
