### THIRD 1992 SUPPLEMENTARY APPROPRIATION

#### Arrangement of Provisions

##### Title

1. Short title
2. Application
3. Grant and appropriation of \$5,776,070 out of the Treasury Fund

1992/1993, No. 6.

AN ACT to authorise the issue and application of additional sums of money out of the Treasury Fund to certain services of the financial year ending with the 30th day of June 1992.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short Title - This Act may be cited as the Third 1992 Supplementary Appropriation Act.
2. Application - Sections 3 and 4 and the Schedule of this Act relate to the financial year ending with the 30th day of June 1992 (herein after referred to the year 1992).
3. Grant and Appropriation of \$5,776,070 out of the Treasury Fund - (1) There may be issued out of the Treasury fund and applied to the services of the year 1992 in addition to the sums appropriated for the year 1992 under the Appropriation Act No.2 1991 as heretofore amended the sum of \$5,776,070.

(2) The sum authorised to be applied by subsection (1) of this section is hereby appropriated to the services expressed in the votes specified in the Schedule to this Act.
