AN ACT to amend section 3 of the Western Samoa Trust Estates Corporation Act 1977 relating to the membership of the Board of Directors for the Corporation.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament as follows:-

1. Short Title and Commencement-(1) This Act may be cited as the Western Samoa Trust Estates Corporation Amendment Act 1992/1993 and shall be read together with and deemed part of the Western Samoa Trust Estates Corporation Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall commence on the date upon which it is assented to by the Head of State.

2. Interpretation-Section 2 of the principal Act is hereby amended by inserting the word "nominee" and its definition in its alphabetical place.

"Nominee" means any Officer or employee of Treasury authorised by the Financial Secretary in writing to exercise the rights and powers conferred by the principal Act on the Financial Secretary.

3. Continuation of the Corporation-Subsection (2) of section 3 of the principal Act is hereby repealed and replaced with the following subsection:-

"(2) From the commencement of this Act, the Corporation shall continue to have a Board of Directors consisting of the following directors:-

- (a) A Chairman;
- (b) A Deputy Chairman;
- (c) The Director of Agriculture;
- (d) The Financial Secretary or his nominee; and
- (e) 5 other Directors."
